4) Updates from Network members

Trish Dunlop - A small networking event is taking place on 25 October in Dalhousie Building, University of Dundee.

Trish spoke about a tool that has been used to evaluate the Mellow Parenting programmes. The tool is accessible and uses graphics. More information about the tool is at www.coresystemtrust.org.uk

Sandy Cruikshank

- A training session took place in August for Children's Hearings Scotland trainers at West Lothian College. Work has been done to create easy read letters to parents with a learning disability and a leaflet regarding Children's hearings
- Bianca talked to over 200 student midwifes at a conference in Hamilton in September
- The Edinburgh Review Team that is made up of people who chair case conferences and Looked After Accommodated Children (LAAC) reviews in Edinburgh are now producing easy read agendas and invite letters
- A meeting has taken place with Ronnie Hill from GIRFEC regarding producing an easy read Child's Plan and easy read letters for GIRFEC meetings
- The Group will be meeting with either the Deputy First Minister or GIRFEC Team about information sharing
- The Parents' Group will be celebrating their 10th birthday party on 26 January 2017.

Following Sandy's update, discussion took place regarding the need for all documents to be easy read as standard.

David Barr – Aberlour Family Service – South Ayrshire is funded by the Big Lottery until September 2017. They have commissioned CEIS and the Social Value Lab to evaluate the sustainability of the service and propose alternative future funding models.

Katie Wanless – Bright Light in Edinburgh is now offering a family counselling service for parents with a learning disability on Tuesdays.

Dominic Jarrett – East Ayrshire is collecting data to find out what has happened since 1998 to families who received intensive support at the time. The information will be shared when it is complete.

Andy Miller – The event to launch the recommendations from the report 'Supporting Parents with Learning Disabilities in Scotland:

Challenges and Opportunities' written by Ailsa Stewart, Gillian MacIntyre and Sharon McGregor has been postponed. This will now take place on 17 November 2016. This is an 'invite only' event and will include parents. People at the event will have sight of the full report with recommendations and will be asked to pull together an implementation plan and name organisations to take the actions forward. The full report and implementation plan will be available early 2017.

5) Esme Fairbairn work plan presentation / discussion

Oonagh gave a presentation about her work to be done between October and December 2016. This included a review of current membership, making sure the Network works together and making the Network bigger.

Members asked what the benefits are of being part of a UK Network.

A UK wide national event was suggested.

Network members discussed how to recruit more social workers into the Network.

Different ideas came from the group about how to involve parents in the Network.

There were questions about the need for parents to attend Network meetings in order to be involved in the Network or if there is another way to involve parents.

Points were made about the accessibility of meetings and presentations.

Andy suggested sending a survey out to members about how best the Network can involve parents and those who cannot attend meetings.

- Send an email asking Scottish Network members to join the UK Network
- Ask Children and Families Social Workers to join the Network
- Answer the Network's question about why it is better to be in a UK Network

 Ask the Network how they think parents could be involved in the Network in the best way.
