Annex B: Local Authority Level Learning Disability Statistics Scotland (2018)

This Annex provides information about adults with learning disabilities known to local authorities, at local authority level.

Any comparisons between the data provided by local authorities should take account of local populations, priorities and geographical circumstances, as well as data quality issues, for example non-response error, which have been flagged where appropriate. In particular, data users should be mindful of missing data across the individual data items.

The 2018 data collection was impacted by the introduction of the General Data Protection Regulation (GDPR) in May. This was true particularly in relation to information that is not collected routinely by local authorities through their Management Information Systems, such as employment and further education data.

Glasgow City Council was unable to return any data about adults with learning disabilities in time for the 2018 collection. To maintain national relevance, the data provided by this authority for 2017 has been included in this report. Because of this, the data presented in this publication are **provisional**. Final data for LDSS 2018 will be published when Glasgow City Council submits its data for the 2018 collection.

Disclosure Control

Disclosure control has been applied to some of the tables in this annex to prevent the release of sensitive information. Where disclosure control has been applied it has been explained in a footnote. Two methods of disclosure control have been used in the annexes:

Suppression of possibly disclosive cells (e.g., where the value is small) which means that the value for that cell in the table is not given as well as secondary suppression of cells which means at least one other value in the row or column is also not given to ensure that disclosive cells cannot be deduced through subtraction.

Rounding of cells to a multiple of a set base such as 5 where for example a true value of 3, 4, 6 or 7 would be shown as 5. This adds uncertainty to the true values of small cells.¹

Please note that while disclosure control has been applied to some local authority values, national totals have remained unchanged. Therefore the sum of local authority values may not add up to national totals.

Tables B1a-c: Adults with learning disabilities known to local authorities (2018)

These figures include adults with learning disabilities who are known to local authorities from contact in the last year. The figures include 16 and 17 year olds who are not in full-time education. This data does not include adults with learning disabilities who are not known to local authority areas. Please see the data quality summary in Annex C, published alongside this Statistical Return on December 18th 2018 for further information.

Glasgow City Council was unable to return any data for the 2018 collection. To maintain national relevance, the data returned from this authority in 2017 has been used.

Of those local authorities who reported in 2018, City of Edinburgh Council reported the highest number of adults with learning disabilities Council (2,167 adults). Orkney Islands Council reported the lowest number of adults with learning disabilities known (87 adults).

There are 5.2 adults with learning disabilities known to local authorities per 1,000 of the population in Scotland². At local authority level, this ranges from 3.2 adults with learning disabilities per 1,000 of the population in East Renfrewshire to 8.5 adults with learning disabilities per 1,000 of the population in East Lothian.

Notes:

- 1. Glasgow City Council (in 2017) and North Lanarkshire Council only returned information on adults with learning disabilities who are in receipt of a service funded by the local authority, rather than those who are known to the local authority, as this is the information which can be extracted from their Management Information Systems. Data users should be aware that the number of adults with learning disabilities in these local authorities and the total number recorded nationally are therefore likely to be an under-estimate. Of the remaining, 30 local authorities returned data as stipulated in the 2018 Data Guidance document.
- 2. There are 1,016 adults (4.3% of **all adults**) included in the Statistical Return who are on the autism spectrum and do not have an associated learning disability.
- 3. The LDSS team within SCLD takes all possible steps to avoid duplicate records appearing in the Statistical Return, including data cleansing and checking processes. However, duplication of records for individuals is possible, particularly when a person is funded by one local authority but lives in and/or receives services in another. Data guidance states that the local authority which provides the majority of funding for an individual should return data on that individual. Where it is unclear which local authority provides the majority of funding, local authorities work together during data collection to minimise duplication of records. It is possible that there may be duplicate records within the statistical return, but the LDSS team estimates this will be a very small proportion of the total, given that numbers of adults with learning disabilities living in a local authority different to that which funds a service for them are low.
- 4. Age (as at 31/3/2018) is calculated from date of birth.
- 5. There are 15 adults whose date of birth has not been recorded. They have been included in the totals column for the number of adults known to local authorities.
- 6. These figures are likely to be an underestimate of the true number of 16 and 17 year olds with learning disabilities, as they do not include 16 and 17 year olds who are in full-time education.
- 7. In 2018, 9 individuals were recorded as 'other specific gender', 'gender not specified' or 'gender not known'. These individuals have not been included in any tables relating to gender, to prevent disclosure of identifying information, but are included in the totals columns in all other tables.

Table B2: Adults who are on the autism spectrum (AS) by local authority area (2018)*

These figures include adults with learning disabilities who are known to local authorities from contact in the last year. The figures include 16 and 17 year olds who are not in full-time education. This data does not include adults with learning disabilities who are not known to local authority areas.

Some adults are recorded as having learning disabilities and as being on the autism spectrum, whereas a small number are recorded as being on the autism spectrum but with no associated learning disability. It is likely that this data represents a significant underestimate of the number of adults who are on the autism spectrum but have no associated learning disability. This is partly due to the fact that the data is collected directly from local authority learning disability services, with which adults on the autism spectrum may not have had direct contact, because they may not be receiving formal support or this may be available from other sources, such as the NHS. However, these figures do provide further information about adults on the autism spectrum who are known to local authority learning disability services.

Glasgow City Council was unable to return any data for the 2018 collection. To maintain national relevance, the data returned from this authority in 2017 has been used. Midlothian Council did not return data on adults with an autism spectrum diagnosis in 2018.

Information on this data item was not recorded for 3,578 adults with learning disabilities (15.3% of **all adults**). Missing data has not been imputed. Data users should be aware that the number of adults on the autism spectrum and those who do not have a diagnosis, are therefore likely to be significantly higher than reported.

4,382 adults known to local authorities in Scotland are recorded as being on the autism spectrum. This is 18.7% of **all adults** known to local authorities in Scotland.

City of Edinburgh Council reported the highest number of adults with an autism spectrum diagnosis (435 adults). This is 20.1% of all adults known to them. East Dunbartonshire Council reported the largest

proportion of adults with an autism diagnosis as a proportion of all adults with learning disabilities known to them (38.5%).

Table B3: Adults with learning disabilities who live with a family carer by local authority area (2018)*

These figures include adults with learning disabilities who are known to local authorities from contact in the last year. The figures include 16 and 17 year olds who are not in full-time education. This data does not include adults with learning disabilities who are not known to local authority areas.

Glasgow City Council was unable to return any data for the 2018 collection. To maintain national relevance, the data returned from this authority in 2017 has been used. Aberdeenshire, East Renfrewshire and North Lanarkshire councils did not provide data for this item.

In total, information on this item was not recorded for 6,476 adults (27.6 % of **all adults**) with learning disabilities across Scotland. Missing data has not been imputed. Data users should be aware that both the number of adults with learning disabilities who live with a family carer and those who do not live with a family carer is therefore likely to be higher than the figure reported.

Just under a third (30.3%) of **all adults** with learning disabilities known to local authorities were reported as living with a family carer.

Clackmannanshire Council reported the highest proportion of adults with learning disabilities living with a family carer, at 55.5% of **all adults** in the local authority area.

Table B4: Adults with learning disabilities living in the same accommodation by local authority area (2018)*

These figures include adults with learning disabilities who are known to local authorities from contact in the last year. The figures include 16 and 17 year olds who are not in full-time education. This data does not include adults with learning disabilities who are not known to local authority areas.

Glasgow City Council was unable to return any data for the 2018 collection. To maintain national relevance, the data returned from this authority in 2017 has been used. Aberdeenshire, East Renfrewshire and North Lanarkshire councils did not provide any data for this item.

Overall, there were 6,251 (26.7%) adults for whom this data was not known by local authorities. Missing data has not been imputed. Data users should be aware that both the number of adults with learning disabilities living as the only person with learning disabilities in their accommodation and the number of adults living with other people with learning disabilities in the same accommodation may be higher, both at local authority level and at national level.

In 2018, 54.5% of **all adults** with learning disabilities known to local authorities were the only person with learning disabilities in their accommodation. Further, 18.8% of **all adults** with learning disabilities known to local authorities live with **at least** one other person with learning disabilities.

Table B5: Accommodation type for adults with learning disabilities by local authority area (2018)*

These figures include adults with learning disabilities who are known to local authorities from contact in the last year. The figures include 16 and 17 year olds who are not in full-time education. This data does not include adults with learning disabilities who are not known to local authority areas.

Glasgow City Council was unable to return any data for the 2018 collection. To maintain national relevance, the data returned from this authority in 2017 has been used. East Renfrewshire Council did not provide any data on this item.

No information was recorded on this data item for 2,888 (12.3%) adults with learning disabilities known to services. Missing data has not been imputed. Data users should be aware that the total number of adults living in mainstream accommodation, supported accommodation, registered adult care home and 'other' accommodation types is likely to be higher than recorded.

In 2018, 13,923 (59.4%) of **all adults** with learning disabilities known to local authorities were living in mainstream accommodation. A further 3,863 (16.5%) adults with learning disabilities known to local authorities were living in supported accommodation, and 1,774 (7.6%) in registered adult care homes.

In 2018, 6,923 (29.5%) of **all adults** with learning disabilities known to local authorities used alternative opportunities and 8,654 (36.9%) did not use alternative opportunities.
